Excluded goods:

Mobile phones, Electronics, Audio/Video-equipment, Computers, data banks and processors and other goods in respect of telecommunication and data processing, if the value of the goods is higher than € 50,000 per each truck and/or storage place.

If not otherwise confirmed, live Animals, removal goods, heavy cargo and salvage cargo are excluded.

Container Liability:

The insurer provides compensation for damage to foreign containers, insofar as these items are provided to the policyholder free of charge in connection with the execution of a freight transport or are themselves counterpart of a freight contract. The replacement obligation is limited to the repair costs, maximum the time value of the container, but not more than € 25,000.00 per claim. The deductible is € 500.00 per each claim.

Insurance period:

The insurance contract is valid from 01.01.2020 until 31.12.2020 and will be renewed tacitly for one year, unless cancelled with three-months notice by either party.
